Discussion of current properties

- Morning Star Baptist Church Catonsville
 - o Alan passed out plans of the building as is and possible Spotlighters use.
 - o The property is well-lit at night.
 - o There is lots of parking.
 - o Asking price is \$3.8 million.
- Sun Papers Building 500 Calvert Street
 - o Fuzz meant with local realtor who works with local developers
 - o A developer is looking to acquire the former Sun Paper building
 - o One level of underground parking, plus the garage next door
 - Tadco is looking to buy the building and leaving Sun Paper with top 3 floors, then grocery store, retail establishments and eateries, five floors of office space
 - o In the middle of the building is 18,000 square feet with 26 foot ceilings, soundproofed, etc. for the printing presses lots of power and lots of cooling
 - Interested in talking to us, President of Tadco is a Blaustein descendant, David Hirschhorn
 - o Parking under the building for office residents, a freight elevator, 4 truck bays,
 - o Talking about donating the space to us (partially or fully)
 - o Negotiations are not finalized
 - o The plan is within 3 years (around early 2019) to have space ready for rental
 - o Glass front lobby off Calvert Street
 - o Possibility of parking beneath building after office hours
